The Derbyshire Challenge – Consultation Guidance

What is the Derbyshire Challenge?

The Derbyshire Challenge is all about how we will deal with huge budget cuts and turn around the county's fortunes.

We're facing massive budget pressures like never before. By 2018, we need to save £157m due to reductions in Government grants, inflation and greater demands on areas of the budget for adult social care and vulnerable children.

We want to discuss proposed changes to services with Derbyshire residents to get their views but we're also legally required to hold a public consultation for many of the cuts we're proposing. Even though we'll be holding many individual consultations we're taking a 'one council' approach. There is already an agreed set of messages, templates and formats for your consultations.

Consultation check-list

A consultation carried out badly could cause your service a lot of difficulty.

If the Council receives a legal challenge from someone who believes our consultation process is flawed it could be an expensive and lengthy process to defend. This could mean your proposals are put on hold along with any potential savings which they aim to make.

But don't worry, help is at hand. If you're starting to think about holding a consultation for your service you don't have to go it alone. There are support services here to help you.

Here are the first three steps you need to take:

- **Talk to legal** to find out whether you need to consult and other guidance on the legal requirements for your consultation, including what you should be asking residents and service users. They can also advise about how to structure your Cabinet reports including the outcome of equality analyses.
- **Talk to policy** to identify who you need to consult with, the type of consultation needed, the number of weeks you need to consult for, advice about lead-in times and help developing your questions. They can also advise whether you will need to carry out equality analysis.
- **Talk to communications** to draw-up a communications plan and for advice on putting your consultation online, producing leaflets, posters and other communications materials, help writing and producing literature and to check your consultation is easy to understand.

Accessing support – How do I find out more?

We're holding a number of sessions to help staff who will be leading consultations in the future.

Each session will be a round-table discussion offering practical support on how to consult and engage with the public. We'll share examples of good practice from within the county council and partner organisations, offer you handy hints and tips, and provide support to help you complete the consultation template which all staff leading a consultation must complete before their consultation starts.
