Whenever a comment or complaint is received we will make sure that

- it is dealt with quickly (within 28 days)
- it is dealt with by the right person
- every effort is made to resolve any problems
- we will apologise if we have made a mistake

What you might complain about

- The process of the conference (or core group) not complying with Derby and Derbyshire Safeguarding Children Board (DSCB) procedures
- The decision about the need for a child protection plan not complying with DSCB procedures
- The outcome of the conference was not reflected in the facts given for the category of primary concern.

Possible Outcome of Complaints

- The Child Protection Conference could be reconvened to consider a specific issue
- A recommendation could be made to the core group for a specific piece of work to be completed
- The matter could be referred to a DSCB sub group to consider a specific point
- No further action considered necessary

Things that you may wish to comment on or make suggestions about

- The quality of service given by a practitioner
- The way the conference or core group is run
- Whether you felt included in the process
- Whether you felt your views were listened to
- The venue and timing of meetings
- The people invited to the meeting
