Question 2: Do you have any suggestions about the additional information or assessments that should be included in the Environmental Statement?

Yes. The Council's suggestions are presented in its response to each of the above documents.

Question 3: Do you have any other comments?

The Council has provided commentary of the overall process and its strategic concerns at the front of its response to Volume1.

It has not been possible to conduct a full analysis of the WDES due to the relatively short consultation period and limited available data. It is the Council's expectation that HS2 Ltd pay due attention to the concerns raised in its response, addresses each point and mitigates accordingly prior to the deposit of the full ES. It is also expected that HS2 Ltd engages directly and meaningfully with the Council in the preparation of work leading to the formal Environmental Statement. This will ensure a robust proposal that communities can have confidence in and may negate the necessity to see amendments through the Parliamentary process in the Commons and Lords.

The County Council's response to the questions raised on the draft Equality Impact Assessment is set out as follows:
